A complete set of bidding document in English may be purchased by the interested bidders upon submission of a formal written application to the office of **Bihadi Rural Municipality, Office of the Rural Municipal Executive, Wahakithanti, Parbat** within office hour, up to and including **2075/12/25 (8th April, 2019)**.
3. Sealed Bids must be submitted to the **Bihadi Rural Municipality, Office of the Rural Municipal Executive, Wahakithanti, Parbat** on or before **12:00** hour of **2075/12/26 (9th April, 2019)**. Documents received after this deadline shall not be accepted.
4. Bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00** hrs on **2075/12/26 (9th April, 2019)** at the **Bihadi Rural Municipality, Office of the Rural Municipal Executive, Wahakithanti, Parbat**.
5. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security for the amount as specified in table below and valid for 30 days beyond bid validity period. If bidder wishes to submit bid security in the form of cash, the cash should be deposited in **Ga 3 Dharauti Account No. 17200201149846000004 on behalf of Bihadi Rural Municipality, Office of Rural Municipal Executive, Wahakithanti, Parbat at Prabhu Bank, Bihadi Branch, Bhusalchowk, Bihadi-04, Parbat** and Submit the receipt of the deposited amount of cash with the bid.
6. All interested bidders are strongly encouraged to attend pre-bid meeting. Pre-Bid meeting shall be held at the **Bihadi Rural Municipality, Office of the Rural Municipal Executive, Wahakithanti, Parbat** on **2075/12/14 (28th March, 2019)** at 13.00 hrs.
7. If the last date of purchasing, submission and opening and pre-bid meeting falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
9. Any conditions so far not covered shall be as per Public Procurement Act-2063, Public Procurement Regulations-2064 and Local Government Financial Regulations 2064.
