2. Only electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before 12:00 pm of 2021/09/15. Bids received after this deadline will be rejected.
3. Sealed Quotations shall be opened in the presence of bidders representatives who choose to attend at 13:00 hours of 2021/09/15 at the office of Bihadi Rural Municipality, Parbat. Bids must be valid for a period of 45 days after bid opening and must be accompanied by bid security valid for 30 days beyond the validity period of the bid.
4. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
5. The person, firm or company black listed as per Public procurement Act-2063 with amendment, shall be ineligible to submit the bid and also the proprietor of such firm or company shall be ineligible to submit the bid from another new firm or company.
6. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063 with amendment and Public Procurement Regulations-2064 with amendment and other prevailing regulations.
